*This application is to fill a vacancy on the Healdsburg City Council. The Healdsburg City Council will review applications in a public setting and may set up a public interview process for each candidate.*

*The Council may decide to make no appointment at all and to call a November 3, 2020 Special Election to fill the seat, to make an appointment until the same Special Election is called (therefore the term on Council would be for roughly 4-5 months), or to not call a Special Election and to make an appointment for the remainder of former Mayor Leah Gold’s term of office (which ends in December 2022).*

*This application is a public document. It will be compiled with other applications and considered by the Healdsburg City Council as a part of a noticed public meeting.*

*Only Healdsburg residents who are registered voters in Healdsburg will be eligible for appointment.*

Please note: At the time you would be named to the Healdsburg City Council, you must be:

- At least 18 years of age;
- A resident residing within the city limits of Healdsburg; and
- A registered voter in Healdsburg.

You must maintain Healdsburg residency and registered voter status throughout your term of office.

Also at the time of appointment (and annually as well as at the completion of your service), you will be required to complete and file a public [Form 700](#) with the California Fair Political Practices Commission. Form 700 filings allow the public to know of any potential conflicts of interest related to your public service. These conflicts can relate to employment, property ownership, loans and gifts, stock ownership, and more. You are also required to disclose certain financial interests of your spouse.

During your term on the City Council, you will be required to identify any potential conflicts (often with the assistance of the City Attorney) and to recuse yourself from voting on or otherwise influencing any action that might cause a financial or other conflict.
