Project description. The property owner has submitted a Historic Demolition Permit application for the demolition of the 1872 Greek Revival residence, known as "The Kimball House" located at 544 Tucker Street. The Kimball house is associated with significant themes or patterns of events (Criterion 1), is associated with the life of a locally important person (Criterion 2), and embodies distinctive architectural characteristics (Criterion 3). The Kimball House lacks sufficient integrity for listing in the California Register and the National Register of Historic Places. The subject residence has been identified as a contributor to the eligible "Tucker Street Historic District." The potential "Tucker Street Historic District" is eligible for listing in the California Register of Historic Resources (CRHR) at the local level. The project includes the proposed demolition of "The Kimball House." No new construction or redevelopment has been proposed.

Probable environmental impacts. Historic Resources

The City of Healdsburg will be the Lead Agency and will prepare a Focused Environmental Impact Report for the project identified above. Responsible and trustee agencies may need to use the EIR when considering a permit or other approval for the project.

We would like to know your views as to the significant environmental issues and possible mitigation measures that should be included in the EIR.
