A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
HEALDSBURG APPROVING THE SELF EVALUATION AND  
TRANSITION PLAN PREPARED BY MOORE IACOFANO  
GOLTSMAN

WHEREAS, Title II of the Americans with Disabilities Act (ADA) requires public entities to operate each service, program and activity so that the service, program and activity, when viewed in its entirety, is readily accessible to and usable by individuals with disabilities; and

WHEREAS, the ADA requires the City of Healdsburg to prepare a Self Evaluation and Transition Plan (SETP) to evaluate its current services, policies, and practices, and the effects thereof that do not or may not meet the accessibility requirements and, to the extent modification of any such services, policies, and practices is required, to recommend necessary modifications; and

WHEREAS, on January 19, 2010 the City Council adopted Resolution No. 9-2010 approving a Professional Services Agreement between the City and Moore Iacofano Goltsman to prepare the SETP; and

WHEREAS, the City provided the public with opportunities to provide input on the contents of the SETP through public meetings and by soliciting comments on the draft SETP through its web site; and

WHEREAS, the SETP identifies barriers to individuals with disabilities and specific barrier removal actions and a priority order is assigned to each action with an estimated cost and timeframe for evaluation; and

WHEREAS, the City will independently evaluate each accommodation pursuant to the schedule contained in the SETP in accordance with the requirements of the ADA; and

WHEREAS, the City has determined that the SETP is exempt from the California Environmental Quality Act (CEQA) pursuant to Title 14, Section 15061(b)(3) of the CEQA Regulations because there is no possibility that it will have a significant effect on the environment as each proposed activity subject to discretionary approval will be subject to future environmental review by the City;

NOW, THEREFORE, BE IT RESOLVED that based on the foregoing, the City Council of the City of Healdsburg hereby approves the Self Evaluation and Transition Plan dated April 2012 as prepared by Moore Iacofano Goltsman.




